- 15. Rates once fixed as above shall not be increased without the approval of the Director, ICAR-IIRMR, Bharatpur.
- 16. IIRMR will not undertake the responsibility for recovery of any outstanding dues in case the contractor sells material on credit.
- 17. The Mess staff will be neat and clean, free from any communicable disease and responsible to the contractor and the IIRMR undertakes absolutely no responsibility with regard to any terms and conditions of their services.
